#### APPLICANT'S SUPPLEMENTARY REPLYING AFFIDAVIT

- I am the Executive Director of the Helen Suzman Foundation (HSF), the applicant in this matter. I was the deponent to the founding affidavit in this application.
- The facts contained in this affidavit are within my personal knowledge, unless the context indicates otherwise, and are true and correct, to the best of my knowledge and belief.
- Where I make submissions on the applicable law, I do so on the advice of the applicants' legal representatives.

#### INTRODUCTION

- The purpose of this affidavit is to address two matters which have arisen after HSF filed its replying affidavit on 29 August 2022:
  - 4.1 The Minister's Directive 2 of 2022, and an accompanying press statement, published on 2 September 2022.
  - 4.2 The limited documents received from the respondents pursuant to the HSF's Rule 35(12) request.

#### THE LATEST DIRECTIVE

On the evening of Friday, 2 September 2022, I received social media alerts that the Minister had issued a new directive and press statement on the ZEPs. I attach a copy of the directive and press statement, as it appears on the Department's website, as "SRA1".

- 6 The press statement announces that
  - 6.1 The "grace period" for ZEPs will be extended for a further 6 months, until 30 June 2023;
  - 6.2 This follows a progress report and recommendation presented to the Minister by the Departmental Advisory Committee (DAC), although the content of that report is not disclosed;
  - 6.3 The purpose of this extension is to afford ZEP-holders "another opportunity to apply for one or other visas and / or waivers provided for in the Immigration Act"; and
  - 6.4 The press statement concludes that "There will be no further extension granted by the Minister".
- 7 The accompanying Directive 2 of 2022 essentially replicates Directive 1 of 2021, albeit that it now extends to 30 June 2022.
- Once again, there was no consultation process before the Minister's latest announcement. It was made without any prior notice to affected ZEP-holders, civil society and the public at large and with no attempt to seek comments on the adequacy of the further extension of only 6 months.
- I emphasise that the Minister's announcement has not changed the essential decision that is under review. The Minister is clear that he will not entertain any further extensions of ZEPs and that he has decided to terminate the ZEP programme.





- In these circumstances, the underlying decision that is target of this review application remains unchanged. All that has changed is the "grace period" afforded to ZEP-holders.
- 11 The HSF accordingly persists in its review application and the grounds of review set out in our existing papers, which apply with equal force to this latest announcement.
- The HSF will file a notice of amendment together with this affidavit, reflecting minor adjustments to the relief sought to address the latest announcement.
- The HSF has also written to the respondents seeking access to the "progress report and recommendation" that led the Minister to issue the latest directive. I attach a copy of this email as "SRA2".
- Pursuant to the request for access to the DAC's report and recommendation, HSF's legal representatives had a telephonic discussion with a Khethani Swuhana of Sigogo Attorneys. In the discussion, Sigogo Attorneys advised that they did not have a copy of the DAC's progress report and recommendation made to the Minister; however, same would be requested from their clients and that Sigogo Attorneys will revert to HSF during the course of the day; on 5 September 2022.
- On 6 September 2022, Sigogo Attorneys wrote to DLA Piper. The letter is not a model of clarity regarding HSF's request for access to the report and recommendation. However, it is discernible from the letter that the respondents





take a technical view that, because HSF did not bring an application in terms of Rule 53, HSF is therefore not entitled to the DAC's progress report and recommendation. There is no substantive reason provided as to why the respondents object to sharing the report and recommendation with HSF and with the Court and none could validly exist. The refusal to provide these documents is not in keeping with the duty of candour that the Minister owes to this Court.

The HSF will be considering what steps to take in this regard and reserves its rights in this regard. However, at present and at the time of filing this affidavit, no copy of the DAC'S report and recommendation was received from the respondents.

#### THE DOCUMENTS RECEIVED FROM THE RESPONDENTS

- In paragraphs 11 to 12 of the replying affidavit, I highlighted the Director-General's failure to be open and transparent with this Court by offering scant information on *inter alia*, how the Department is currently handling ZEP-holders' applications and representations. This led to the delivery of a Rule 35(12)/(14) request. Copies of the correspondence in this regard are attached as annexures "RA1", "RA2" and "RA3" to the replying affidavit.
- On 1 September 2022, Sigogo Attorneys, the respondents' attorneys of record (Sigogo) delivered documents in partial compliance with the Rule 35(12)/(14) request made by HSF. I respond to the documents below.

## The limited number of documents received

- The Director-General alleges in the answering affidavit that 6,000 of the approximately 178,000 ZEP-holders have taken the opportunity to make representations to the Minister, however, the respondents' attorneys have only provided approximately 400 representations, which is a fraction of the figure provided by the Director-General in the answering affidavit.
- The last day for Sigogo to respond to the Rule 35(12)/(14) request was 5 September 2022 and as at the date of this affidavit, just over 400 of the so called representations have been delivered. The respondents have therefore failed to properly respond to HSF's request in this regard.

#### Contents, nature and purpose of the documents

- The Director-General characterises the email correspondence received from ZEP holders through the ZEPenquiries@dha.gov.za email address as "representations" and further states that the nature and purpose of these "representations" was for, "both the non-extension of exemptions and the 12-month extension period".² Elsewhere, the Director-General stated that the 6000 ZEP holders who made "representations" were effectively applying for individual exemptions under section 31(2)(b) of the Immigration Act.³
- This cannot be the case, in view of the fact that the vast majority of the emails received by the Department from ZEP holders are queries relating to the

procedure and requirements for obtaining alternative visas/permits, and desperate pleas for assistance and information on how to apply for alternative permits. These emails are in no way applications for individual extensions of their ZEPs, nor are they applications for individual exemptions, as alleged by the respondents.

- In this regard, I attach hereto as annexure "SRA3", extracts of emails from ZEP holders sent to the ZEPenquiries@dha.gov.za email address. Due to the size of the documents, I do not attach copies of all the Documents provided. However, a complete copy of the Documents will be provided to the Court at the hearing of this matter.
- 24 From these emails, it is evident that the senders are desperate for direction on how to regularise their stay and are not making any applications or representations as the Director-General has alleged they are pleading for assistance. For example:
  - 24.1 A parent of two children one about to enter high school and the other in her second year of university tells the Department that without the ZEP, their children will have to put their education on hold and ultimately leave the only country that they have ever called home. Clearly confounded about their family's next steps, the sender ends the email by simply pleading for help and offering to supply any documentation that may help avoid hardship for their children;
  - 24.2 Another parent thanks the Department for the peace of mind that the ZEP has brought his family since they were forced to flee Zimbabwe's





political violence in 2008. Yet, the sender's fears of violence have not subsided over the years and he begs the department for "another chance" at staying in South Africa; and

- 24.3 One ZEP holder takes to emailing the Department after having already tried to obtain the requisite certificate from the Department of Labour *en route* to clearing the way for a work visa application. The sender relays their experience that the Department of Labour is no longer issuing these certificates and signs off with a plea for help, now finding themselves "stuck" with nowhere to turn.
- These pleas for assistance were met with automated responses. The automated response merely directs senders to "consult vfsglobal.com website for all visa and permit information" in the event that they do not receive a substantive reply.
- This can only imply that the ZEPenquiries@dha.gov.za email address was never designed to deliver the Minister representations that would inform his decision to terminate the ZEP but rather to receive general enquiries about the regularisation process under the Immigration Act.
- There is no evidence that ZEP holders received any substantive responses or meaningful assistance with their queries. Nor is there any evidence that these responses were brought to the attention of the Minister.
- 28 This all demonstrates that the ZEP holders were never afforded a genuine opportunity to influence the Minister's decision to terminate the ZEP.





#### LEAVE TO FILE THIS AFFIDAVIT

The HSF respectfully requests this Court's leave to file this further affidavit, in terms of Uniform Rule 6(5)(e). The events addressed in this affidavit arose after the filing of the replying affidavit. They are also material to the decision under review and it is essential that the Court be apprised of these facts.

MINISTER'S IMMIGRATION DIRECTIVE NO: 2 OF 2022

IMPLEMENTATION OF THE DECISION TO EXTEND ZIMBABWEAN NATIONALS' EXEMPTIONS GRANTED IN TERMS OF SECTION 31(2)(b), READ WITH SECTION 31(2)(d) OF THE IMMIGRATION ACT 13 OF 2002

I, Dr PA Motsoaledi, MP, Minister of Home Affairs having, with the powers bestowed upon me in terms of section 31(2)(b), read with section 31(2)(d) of the Immigration Act, decided to extend the Zimbabwean exemptions granted to Zimbabwean nationals for a further period of 6 months in order to allow the holders thereof to apply for one or other visas provided for in the Immigration Act that they may qualify for, hereby direct that this decision should be implemented as follows, during the further six months' period, from 31 December 2022, ending on 30 June 2023:

No holder of the exemption may be arrested, ordered to depart or be detained
for purposes of deportation or deported in terms of the section 34 of the
Immigration Act for any reason related to him or her not having any valid
exemption certificate (i.e permit label / sticker) in his or her passport.

The holder of the exemption permit may not be dealt with in terms of sections 29, 30 and 32 of the Immigration Act

- 2. The holder of the exemption may be allowed to enter into or depart from the Republic of South Africa in terms of section 9 of the Act, read together with the Immigration Regulations, 2014, provided that he or she complies with all other requirements for entry into and departure from the Republic, save for the reason of not having valid permit indicated in his or her passport; and
- 3. No holder of exemption should be required to produce—
  - (a) a valid exemption certificate;
  - (b) an authorisation letter to remain in the Republic contemplated in section 32(2) of the Immigration Act when making an application for any category of the visas, including temporary residence visa.

# PRESS STATEMENT: ZIMBABWEAN NATIONALS GRANTED EXEMPTIONS IN TERMS SECTION 31(2)(b) OF THE IMMIGRATION ACT 13 OF 2002

1. As previously communicated, the Department of Home Affairs ("DHA") appointed the Departmental Advisory Committee ("DAC") led by Dr Cassius Lubisi to assess the visa applications lodged by the affected Zimbabwean nationals. The DHA also appointed an outside legal firm to handle all court challenges relating to the decision not to extend the exemptions granted to the Zimbabwean nationals and related matters.

## Progress report

2. The Minister of Home Affairs ("Minister") received a progress report from Dr Cassius Lubisi. The report states that the DAC has met on several occasions in order to execute its mandate, and their last meeting was held for the whole day on the 1<sup>st</sup> of September 2022. The DAC recommended to the Minister that in view of the progress thus far, it will be prudent for the Minister to consider extending the period within which the affected Zimbabwean nationals will have an opportunity to apply for visas and / or waivers for a futher six months.

3. The Minister has carefully considered the request and decided to extend the period by a further six months, that is, 31 December 2022 to 30 June 2023.



Another factor considered by the Minister is that few Zimbabwean nationals have thus far applied for visas and I or waivers. To this end, the Minister has issued another Directive annexed hereto marked "A"

- The Minister is committed to affording the affected Zimbabwean nationals another opportunity to apply for one or other visas and / or waivers for in the Immigration Act.
- The Directive containing the decision of the Minister will be communicated through diplomatic channels to the Zimbabwean Ambassador in South Africa. Ŋ.
- The DHA calls upon all the affected Zimbabwean nationals to make use of this window of opportunity and not wait for the last moment to lodge their applicantions as is the case now. တ်

There will be no further extension granted by the Minister.

- 1. By the direction of the Minister of Home Affairs, I address this letter to you on his behalf.
- 2. Kindly note that the Minister of Home Affairs has exercised his powers in terms of section 31(2)(d) of the Immigration Act 13 of 2002 not to extend the exemption granted to you in terms of section 31(2)(b) in 2019.
- 3. In order to avoid unnecessary prejudice, the Minister has also imposed a condition giving you a period of 12 months in order to apply for one or more of the visas provided for in the Immigration Act. In other words, your permit which is due to expire on 31 December 2021 will be regarded as valid until 31 December 2022.
- 4. The Minister has issued a directive to the immigration services and all officials to the effect that no action should be taken against the Zimbabwean exemptions' holders in terms of sections 29, 30 and 32 of the Immigration Act.


